



Terms and Conditions of Use for KELVIN-PD Website

Introduction

These terms and conditions apply between you, the User of this Website (including any sub-domains, unless expressly excluded by their own terms and conditions), and Machine Medicine Technologies Ltd, the owner and operator of this Website.
